Description: Haz Mat Technician/Specialist-Weapons of Mass Destruction (WMD)

This course concentrates on response to terrorist incidents involving CBRNE devices for hazardous materials responders, complies with requirements for the State of California's Hazardous Substances Incident Response Training Education program (Government Code Section 8574). This code requires the California Emergency Management Agency to present to field responders approved training classes, taught by trained instructors, in hazardous substance response. These training classes are to be provided through outreach programs and are to certify participants who have completed these training classes. The regulations covering the requirements and course contents are contained in the California

Code of Regulations Title 19-Section 2520.
